Project Description: Using Measure M funds, Orange Coast College will be constructing a new 75,000 square foot multi-disciplinary complex consisting of lecture space, faculty offices and computer labs. This project will be delivered via multiple prime delivery method with construction commencing in August 2013 and classes beginning in the new facility in August of 2015.

Each bidder shall be a licensed contractor pursuant to the Business and Professions Code §7028.15 and California Public Contract Code §3300. The District requires that the bidder possess at the time of bid and maintain throughout the duration of the contract the following classification(s):
