

Bid # 2015 Questions & Answers

1. Sections D Scope of Work item #4 specifies the install/upgrade/configure of Exchange 2012 servers as required. **Response: The District has decided to utilize Exchange 2010, instead of Exchange 2012.**

2. You mention in the RFP 4,000 desktop and servers, how many of each and in which domain?

**Response:**

- a. CCC - 750 non-student / 1,100 student / 80 servers
- b. DIST - 200 non-student / 190 servers
- c. OCC - 1,550 non-student / 1,600 student / 190 servers
- d. GWC - 800 non-student / 1,200 student / 115 servers

**Answer: 3,300 non-student desktops, 3,900 student desktops, and 575 servers**

3. VMware View, are the VDI desktops persistent, non-persistent or Hybrid?

**Response: Included in 1 above.**

- a. CCC – 150 VDI
- b. DIST – 0
- c. OCC - 0
- d. GWC – 115 VDI, hybrid - persistent for staff (pano) and link clones for math labs (with old dell desktops)

4. You mention please estimate storage and design accounting for 5 years growth. Is that just Exchange storage (mailboxes, journaling, archiving, etc.)?

**Response: Yes, storage estimation is just for Exchange mailboxes, journaling and archiving. Please note that Exchange is just for non-student users.**

5. D. Scope of Services, 1F addresses security – Anti-Virus, spam filters, IPS/IDS, Firewall. Are you asking to re-design and include new products for this proposal, OR design around existing solutions?

**Response: Please propose a new solution. However, many sites prefer to work around existing SPAM FILTERS-AV-IPS/IDS and Firewalls where possible.**

- Spam Filters: 1 site has McAfee, 2 sites have IronPort, and 1 site has Barracuda
- Anti-Virus: 2 sites have McAfee, 2 sites have Sophos
- 2 sites have UTM's and 2 sites have traditional Firewalls
