Project Description: Using Measure M funds, Orange Coast College will be constructing a new 75,000 square foot multi-discipline instructional complex consisting of lecture space, faculty offices, and computer labs. This project will be delivered via multiple prime delivery method with construction commencing in August 2013 and classes beginning in the new facility in August of 2015.

Each bidder shall be a licensed contractor pursuant to the Business and Professions Code §7028.15 and California Public Contract Code §3300. The District requires that the bidder possess at the time of bid and maintain throughout the duration of the contract the following classification(s):

The prequalification package must be received by the Office of Purchasing, at the above identified address, no later than Friday, May 24, 2013 at 11:00 a.m. Only prospective bidders deemed to be “pre-qualified” by the District will be eligible to submit bids for the above listed trade categories. A **MANDATORY pre-bid job-walk** will be held at 8:00 a.m. June 12, 2013 and June 18, 2013 at 2701 Fairview Rd., Costa Mesa, CA 92626. Contractors are required to attend ONE of the two job-walks.

Incomplete, inaccurate, or untrue responses or information provided therein by a bidder shall be grounds for the District to reject such submissions for non-responsiveness.
